RULEBOOK

DEFINITION CLAUSE

1. **“Competition”** shall refer to the National Policy Drafting Competition, 2024.
2. **“IST”** shall refer to the Indian Standard Time.
3. **“Organizing Committee”** shall refer to the Organizers of the given Policy Drafting Competition.
4. **“Preliminary Round”** shall refer to the Written Submission of the Policy Drafts made that will determine which teams shall advance to the Final Round.
5. **“Rules”** shall refer to the Official Rules of the Competition and shall apply to any supplementary Rules published by the Organizing Committee.
6. **“Team Code”** refers to the unique code allotted to a Team after the completion of their registration process.
7. **“Written Submission”** refers to the Submission of the Policy Draft in the Preliminary Round.

CONCEPT NOTE

The theme of this competition is **‘Equal Justice, Accessible Paths: Legal Aid Policy Making Competition for Divyaangjan’**.

Specially Abled or "Divyaangjan" are one of those vulnerable sections of society, who face myriads of challenges in their day to day life. There are legislations and government schemes in place to ensure their rights. However, legal guarantees have proven to be insufficient in ensuring equal access to justice for the specially abled at ground level. This competition seeks innovative policy solutions to bridge the gap and create an inclusive legal aid ecosystem for the specially abled community. The aim of this competition is to enhance creativity & practical problem solving aptitude of students, and to encourage them in creating innovative policies that can ensure effective & accessible legal aid to the specially abled in India.

PUBLIC POLICY

PROBLEM STATEMENT

Meera, an 18 year old girl with strong determination, made her way into the merit list of a premier law college of her state. Being a diligent and sincere student, Meera worked very hard to ace the entrance test of her college, and even attained a scholarship. This achievement, brought immense joy to not only Meera, but also to her parents. Meera still recalls vividly the day her results got out. Meera's father, who used to work as a daily wage labourer at construction sites, and her mother, who used to work as domestic help to financially support her husband, shed tears of joy on hearing the news. Patting their wonderful daughter's head, the couple was brimming with joy over the fact that their daughter would be the one breaking the shackles of poverty and societal stereotypes in their family. The parents of Meera stood proud, as their special daughter had achieved something very special.

Meera, was indeed special. She was deaf since birth. However, she never considered this to be a hindrance in her development. Her parents put her in a normal school, as they believed in equality. The support received by Meera from her parents gave her the confidence to pursue her dreams.

Fast forward to present, Meera has completed a semester in college. Meera is no more the jolly and confident person she used to be. Her classmates continuously ridicule her for being deaf. Even her seniors bully her. One day, she was going to college with her friend, Anand, who was also a special child, having lost both his legs in a car accident. It was then when a group of boys of his college passed sexually coloured remarks on her. When Anand confronted them, they slapped Anand, threw him out of his wheelchair and ran away.

This incident had a very disturbing effect on both Meera and Anand. They immediately went to the nearest police station, to report the incident. Meera tried narrating the incident to the police officers, but they could not comprehend her sign language. Meera asked for an interpreter, but the police officers told her that they did not have any. As a result, Anand narrated the entire story, and asked for a lawyer, to seek legal action against the perpetrators.

PROBLEM STATEMENT

The police arranged a lawyer empanelled under the Legal Aid Scheme of the government. The police and lawyer then interrogated Anand and Meera, in order to register a complaint. However, both of them felt that they were insensitive in their conversational approach. Both Anand and Meera got uncomfortable after the interrogation, and became indifferent towards the police and lawyer. The police officers and lawyer had no clue about this sudden behavioural change in the two. Frustrated by the entire discourse, Anand and Meera left the police station, disappointed in the efficacy of the justice delivery mechanism for the specially abled.

The story of Meera and Anand, though fictitious in nature, highlights some of the key challenges faced by specially abled people in seeking justice in India. As per Census 2011, the number of Persons with Disabilities in the country are 2.68 crore, which is 2.21 percent of the total population of the Country. The National Crimes Records Bureau (NCRB) prepares statistical report of crimes committed in India, but unfortunately, it does not have a disaggregated data highlighting the crime rate against specially abled. However, research by independent non-profit organisations reveal that crimes against specially abled have been on the rise. Although there are legislations such as The Rights of Persons with Disabilities Act, 2016, The Legal Services Authorities Act, 1987 and government schemes in place to ensure legal aid & assistance for protecting the rights of 'Divyaangjan', there are loopholes present in the law, such as limited scope and inadequate remedies, which coupled with ethical considerations of societal stigma, insensitivity of people towards specially abled etc. further dilute the object of the legislations. There is also an absence of care-based approach in dealing with cases relating to abuse or exploitation of specially abled, which results in them feeling marginalised by the country's legal aid system. This, it is high time that we move from the idea of "legal aid," towards the idea of "inclusive legal aid."

The Central Government, being committed to the welfare of specially abled, has constituted a high level Committee, in order to invite policy recommendations to ensure better access to legal aid and justice for specially abled. You have been appointed as members of this committee to propose an appropriate policy.

LANGUAGE OF THE COMPETITION

The official language of the Competition shall be English. Therefore, all final rounds, including policy drafts, shall be in English.

MODE OF THE COMPETITION

The Competition would be held virtually, on the video conferencing platform, Zoom.

COMPOSITION OF TEAMS

- Each participating team shall consist of 2 members.
- Participants are not allowed to form inter-institutional teams for the Competition.
- A maximum of Four teams per law school are allowed to participate.

FORMAT OF THE COMPETITION

The competition will have 2 stages:

1. Preliminary Round: This involves the submission of policy drafts within the stipulated timeline.
2. Final Round: It involves the presentation of top 5 policies selected by Evaluation Committee, before a panel comprising esteemed personalities.

ELIGIBILITY

Participation is open to all undergraduates, enrolled in a five-year or three-year law programme, of any recognized College/ Institution/ University.

ANONYMITY OF THE TEAMS

- Each participating team shall be provided with a Team Code post successful registration.
- All communications shall be made through this Team Code.
- The Written Submission shall not bear the logo, name, etc. of the Team, its members or the Institution/College/University represented by the Team. Violation of this rule shall result in disqualification of the team.

TERMS OF USE

All intellectual property rights associated with the policies drafted by participants in the National Policy Making Competition shall be reserved by the Organizing Committee. Participants will be deemed to have granted the Organizing Committee a non-exclusive, irrevocable, royalty-free license to use, reproduce, modify, publish, and distribute the policy proposals for any purpose related to the competition, policy development, or public education. The Organizing Committee will attribute co-authorship to the participants in any such use.

AMENDMENTS TO RULES

The organizing committee reserves the rights to alter any rules or add any rules for the competition at any time before the commencement of the competition. In exercising such right, the Organising Committee shall provide reasonable notice to the participants.

All participants shall be awarded E-Certificates of Participation. Furthermore, the 5 shortlisted teams for policy presentation round shall also be awarded Certificates of Merit.

Note: The trophies and certificates of winners and runners-up shall be sent by post to their respective institutions.

REGISTRATION PROCESS

1. All interested students shall be required to register for the competition in order to be eligible to participate in the same before **30.03.2024 (11:59 PM)**.
2. The registration fee is **Rs. 700/- (inclusive of GST)**. The same shall be non-refundable.

4. The teams shall ensure that the details filled by them in the above form are correct, as they will be used for preparing certificates.
5. The payment of the registration fee must be made according to the payment guidelines provided in this brochure. For payment details, kindly refer to the Payment Guidelines section of the brochure.
6. The registration shall be deemed to be successful only when the participating team receives confirmation of mail along with their team code from the Organising Committee.
7. Any changes in the contact details of Team members must be notified to the Organising Committee through mail at the earliest.

SUBMISSION GUIDELINES

1. The name of the document must be 'Team Code: Policy Draft Submission'. Furthermore, the subject of the submission mail should be 'Team Code- Written Submission | Policy Draft'
2. The submissions can be made in both .doc and .pdf format. The file should not be password protected.
3. All the submissions shall be made through mail at samatva.indore@nmims.edu before **05.04.2024 (11:59 p.m)**.
4. No submissions shall be entertained post the submission deadline.

FORMATTING GUIDELINES

1. The language of policy draft must be English and it shall not be indecent or defamatory. The language shall also not hurt any religious, socio-cultural or political sentiments of any person.
2. The Main Body must be in Times New Roman, 12 points, 1.5 line spacing, Justified, and 1-inch margins on all sides.
3. The relevant sources/ references must be mentioned as footnotes.
4. The Footnotes must be in Times New Roman, 10 points, 1.0 line spacing, Left Aligned.
5. The Footnotes must strictly conform to the standards laid down in the Bluebook 21st Edition (July, 2020).
6. Cover Page: The Cover Page has to be designed page, mention the title of the Policy Draft, and other details (i.e., the Team Code).
7. The written submission shall not exceed ten pages (excluding the cover page).
8. The written submission shall contain the following :
 - Cover Page with the Team Code in the upper right-hand corner and a suitable title for the Policy Draft.
 - Introduction
 - Target Groups
 - Analysis of existing legislations and schemes, and the loopholes present in their implementation
 - Judicial Approach
 - Need for new policy
 - Object of the policy
 - Policy Recommendations.
 - Conclusion

GENERAL GUIDELINES

1. Usage of AI Tools such as ChatGPT and Gemini is strictly prohibited.
2. Paraphrasing as well as verbatim usage of content without appropriate citation of authorities shall amount to plagiarism. A maximum of 7% plagiarism is allowed.
3. The organizers reserve the right to amend any condition or rule in the competition.
4. Non-adherence to any of the guidelines may lead to disqualification of the participants.
5. The decision of organising committee shall be binding in case of any dispute.

PRESENTATION GUIDELINES

1. Five policy submissions would be shortlisted by the Evaluation Committee, and those Participating Teams will qualify for the Presentation round of competition.
2. The Presentation Round of the competition shall consist of deliberations on the policy prepared by the participants.
3. Deliberations shall be made through a PowerPoint Presentation prepared by the Participants.
4. Each team shall be allotted 20 minutes for presentation. Out of the 20 minutes, 15 minutes shall be allotted for policy deliberation & 5 minutes shall be a question-answer session with the judges.

DRESS CODE

The Dress code for the Competition is Court Formals. Court formals shall include following attire.

- **Males:** White Shirt, black trousers, black coat & black tie.
- **Females:** White Shirt, black trousers, black coat & black tie or white kurta, black salwar, black coat

FORMAT OF PRESENTATION

1. Presentation shall include the following slides:

- a. Title Slide
- b. Policy issue
- c. Current Landscape
- d. Proposed Policy
- e. Policy Benefits
- f. Implementation Plan
- g. Conclusion & Call to Action

2. The presentation **must not exceed 15 slides**.

3. Presentation is expected to be clear, concise and based on data, statistics, and visuals.

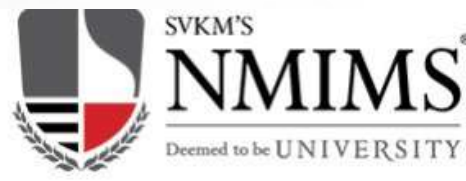
